2. In Government letter third above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Physiotherapy college has fulfilled the conditions prescribed by the Government in the Government Orders first to second read above.

In his letter fourth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Chairman, Sri S.N.S. Charitable Trust, Coimbatore to start four years Bachelor of Physiotherapy (BPT) Course in the name and style as "SNS College of Physiotherapy", Coimbatore with an annual intake of 100 seats from the academic year 2020-2021.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Chairman, Sri S.N.S. Charitable Trust, Coimbatore to start four years Bachelor of Physiotherapy (BPT) course with an annual intake of 100 (hundred) students in the name and style as "SNS College of Physiotherapy", in S.F.No.20/1 pt, SNS Kalvi Nagar, Sathy Main Road, Saravanampatti, Coimbatore District - 641 035 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.81, Health and Family Welfare (PME.2) Department, dated: 14.03.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building completion certificate from the competent authority i.e. PWD Engineer.
- ii. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University, Chennai.

5. The Director of Medical Education is directed to take necessary further action accordingly.
